**CONSIDERING** that the participant is aware that participating in the scheduled events constitutes a  
**HAZARDOUS ACTIVITY with intrinsic dangers**, he has voluntarily enrolled in this event, **despite all  
known and unknown risks of serious bodily injury and / or death** in training for or when attending the  
event and

**CONSIDERING** that the participant understands that this agreement is a general waiver that precludes the  
participant from making any claim of assault and / or death in any way connected with training for or  
participation in the scheduled Event; and

**CONSIDERING** that the participant knows his / her own abilities and limits regarding the events to which  
he / she is registered  
**the participant** expressly and voluntarily **agrees to the following**, regarding to admission to participate in  
these scheduled events:

- 1. TO ASSUME ALL HAZARDS** of bodily harm and / or death resulting from attending and / or training for  
the scheduled events;
- 2.** to check the site [the course] before training or before or during participation of any event;
- 3. TO DISCLAIM ALL CLAIMS** the participant may subject to the Ästhetiker association, their Officers,  
Agents, Employees, Managers, Subsidiaries, and all Insurance Companies for any Losses, Damages,



Injuries, or financial Expenses which participants, or the relatives of the participant suffer, and which are a consequence of the participant's training for or participation in any scheduled event, **for any cause including, but not limited to negligence** on the part of the Ästhetiker Association, its officers , Representatives, employees, directors, affiliates, sponsors, affiliates and any organizations or persons employed to perform any functions related with the Zillertal Valley Ralley, as well as all volunteers;

The Ästhetiker Association and its officers, agents, employees, directors, shareholders, affiliates, sponsors and all insurance companies to **RELEASE FROM LIABILITY AND TO ASSUME LIABILITY ["HOLD HARMLESS"]**, for any loss, damage, injury or financial Expenses incurred by the participant or relatives of the participant, and which are a consequence of the participant's training for or participation in any scheduled event, **for any cause including, but not limited to negligence** on the part of the Ästhetiker Association, their officers, agents, employees, directors, sponsors, affiliates and any organizations or persons employed to perform any functions related with the **ZILLERTAL VÄLLEY RÄLLEY**, as well as all volunteers;

5. That this agreement is interpreted in accordance with the law of the Austrian State.

6. That any disputes concerning the execution of this agreement are submitted to the court of the Austrian State and that they are not transferred to another state.

7. It is noted that photos and/or videos are made at the venue and may be published for the purpose of documenting the event.
